### **Mission Statement:**

To raise awareness of reasons for protecting the life of the preborn, to recognize an SELU student who has demonstrated coinciding ethics, and to promote the services of Restoration Pregnancy Resource Center.

### **Criteria:**

Recipient should:

Be a Full Time SELU student in Junior or Senior year.

Have an overall 3.0 minimum GPA.

Demonstrate exemplary ethics and professionalism

### **Selection:**

The Board of Directors of Restoration House shall annually select a student based on the application, academic transcript, and essay on the sanctity of life before birth. This shall be done annually in May.

### **Amount:**

One \$500 annual award will be donated by Dr. Bill Black until such time that an endowment of \$10,000 is accumulated. This endowment will be managed by SLU and its proceeds will provide an annual award. The award will be cash/check to recipient.

### **Time:**

Applications will be distributed by various student organizations and Restoration House. Applications will be due April 30 of each year at Restoration House.

Recipient will be selected by the Restoration House Board Scholarship Committee and the award given yearly each May by cash/check to recipient.

### **Presentation of Award:**
